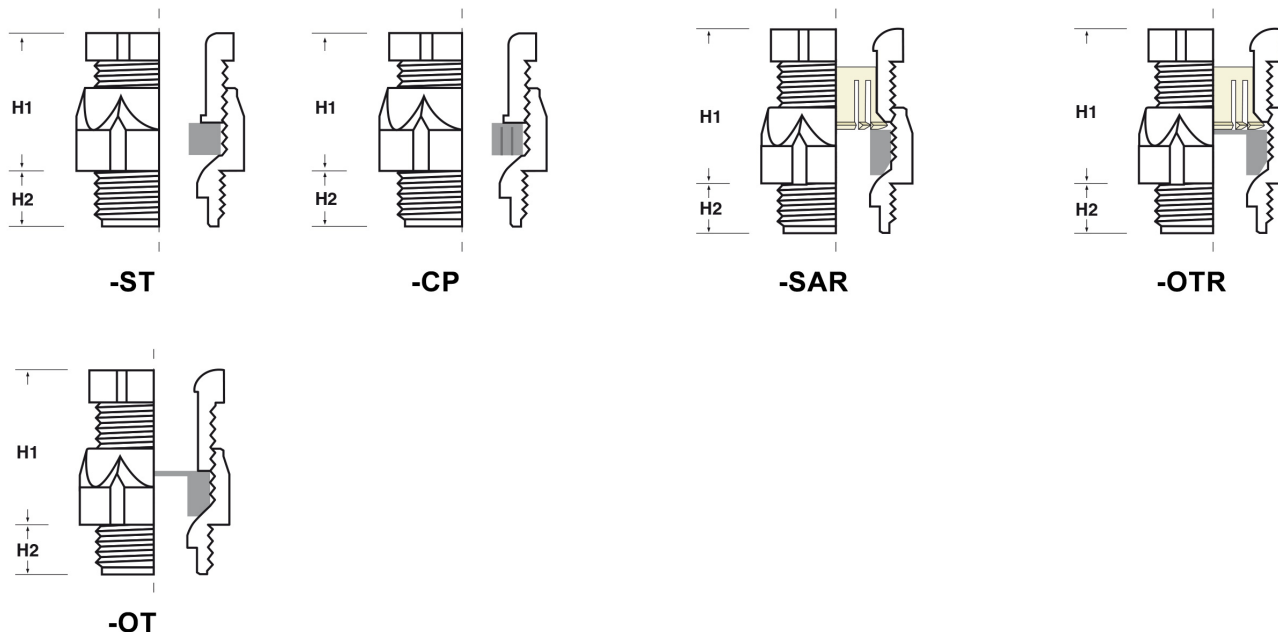

Color: grigio chiaro RAL 7035.

Gasket: -ST (standard), -CP (a "cipolla"), -SAR (sagomata con griffe), -OT (otturata), -OTR (otturata con griffe)

Use temperature: EPA-ST e EPA-CP -40°C / +60°C, EPA-SAR e EPA-OTR -25°C / +120°C, EPA-OT -40°C / +135°C.

IP protection: IP 65
